Our mission is to eliminate substandard housing in Rockbridge County by partnering with the community to make safe, decent, affordable housing a matter of conscience and action.

Rockbridge Area Habitat for Humanity independently owns and operates two ReStores which accept donations of new and used, quality merchandise. They sell a constantly changing inventory of diverse merchandise to the public at a fraction of the retail price, while diverting reusable household items and building materials from area landfills. Sales of donated items help Habitat for Humanity partner with local families to build, rehabilitate, and repair safe and affordable homes in Rockbridge County.
